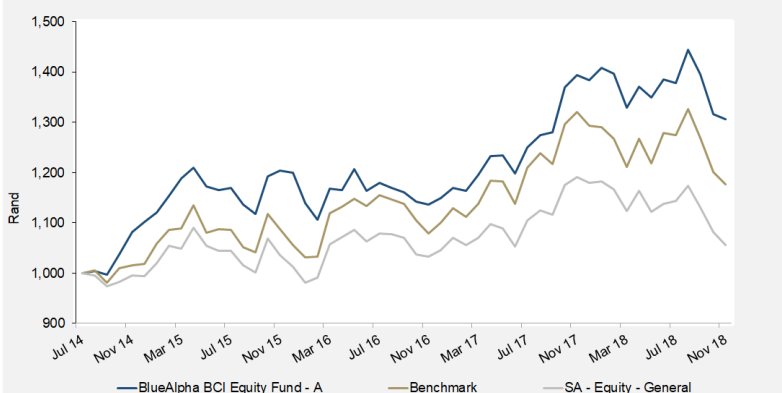
To deliver a high long-term total return for investors. The Fund aims to consistently outperform its benchmark and achieve a top quartile sector ranking

The portfolio may also hold unlisted instruments; namely forward currency, interest rate and exchange rate swap transactions. The portfolio is constructed on a bottom up selection basis focusing on sustainable long term value creation
