INVESTMENT OBJECTIVE

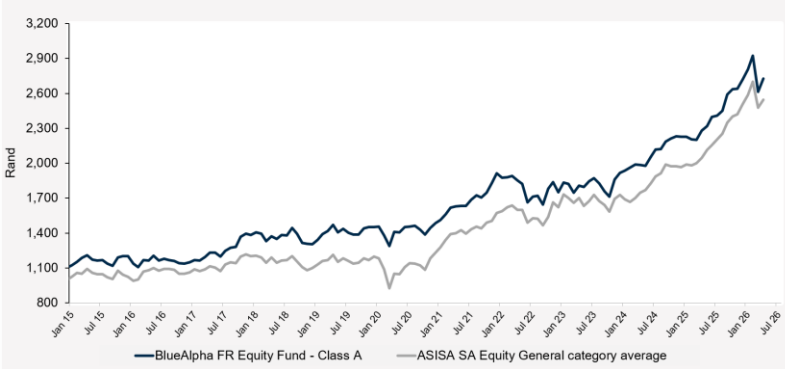
To deliver a high long-term total return for investors. The Fund aims to consistently outperform its benchmark and achieve a top quartile sector ranking. The portfolio is constructed on a bottom-up selection basis focusing on sustainable long term value creation

INVESTMENT PHILOSOPHY

The BlueAlpha FR Equity Fund is a general equity portfolio with the objective to deliver a high long-term total return. The portfolio will invest predominately in local equity securities and the portfolio's minimum equity exposure will exceed 80% of its net asset value. The portfolio's investment universe consists of both local and global equity securities, preference shares, money market instruments, property shares and property related securities listed on exchanges and assets in liquid form as well as participatory interests in collective investments schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

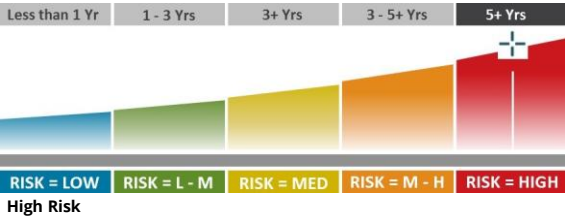

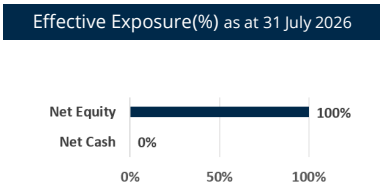
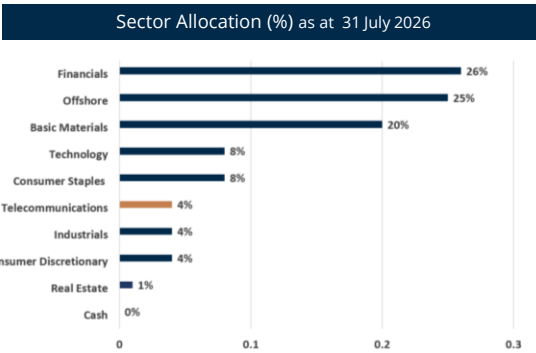
